
Essays on African Politics, Genocide, Literature Herbert Ekwe-Ekwe

The essays here underscore Herbert Ekwe-Ekwe's continuing optimism about the possibilities of Africans constructing post-'Berlin-states' as the launch pad to transform the topography of the African renaissance. Readings from Reading is a timely publication, coming on the eve of the historic January 2011 referendum in south Sudan in which the people of the region will chose to vote to restore their national independence or get stuck hopelessly in the Sudan, the first of the "Berlin-states" that Africans tragically "inherited" in January 1956. Ekwe-Ekwe insists that the contemporary Africa state, imposed on Africans by a band of European conqueror states and currently run by what the author

describes as a "shard of disreputable African regimes to exploit and despoil the continent's human and material resources", cannot serve African interests. The legacy, as this study demonstrates, has indeed been catastrophic: "The [African] overseers pushed the states into even deeper depths of genocidal and kakistocratic notoriety in the past 54 years as the grim examples of particularly Nigeria, the Democratic Republic of the Congo and the Sudan ... depressingly underscore. 15 million Africans have been murdered by African-led regimes in these states and elsewhere in Africa since the Igbo genocide of 1977-1970". This is an engaging, incisive, wide-ranging and multidisciplinary discourse, salient features that have come to define Ekwe-Ekwe's groundbreaking scholarship of the past three decades.

# WILD PLANT NOMENCLATURE AND TRADITIONAL BOTANICAL KNOWLEDGE AMONG THREE ETHNOLINGUISTIC GROUPS IN NORTHWESTERN ETHIOPIA


Botanists study plants. Ethnologists study ethnic groups including their language. Ethnobotany is an interface between botany and ethnology dealing with the perception of ethnic groups about plant life surrounding them. Language, as the mirror of the mind of speakers, is central in ethno-botanical studies. This work describes the linguistic properties of wild plant names and traditional botanical knowledge among three ethno-lingistic groups in northwestern Ethiopia: Awi, Gumuz and Shinasha. The ethno-lingistic groups speak Awni

(Cushitic), Gumuz (Nilo-Saharan) and Shinasha (Omotic) languages, respectively. The purpose of this study is to document the names and uses of wild plants from three ethno-linguistic communities of Ethiopia: the Awi (A), Gumuz (G), and Shinasha (S) - henceforth AGS. The study also attempts to describe the traditional botanical knowledge of these groups in the identification and classification of their plant life.

# NDEH NTUMAZAH. A Conversational Auto Biography Edited by Linus Asong and Simon Ndeh Chi

This rich conversational auto-biography tells the story of the political life of Ndeh Ntumazah who was born in Mankon in 1926, spent the best part of his life suffering and sacrificing for the freedom of Cameroon, and died in London on January 21, 2010, at the age of 83, as President of the Union of the Populations of Cameroon (UPC). Ntumazah was a political activist for nearly 60 years. He joined the UPC around 1950 and remained a militant of the party until his demise. When the UPC was banned in French Cameroon in 1955, he was advised by his comrades to create another party in the Southern Cameroons, which would be the UPC in disguise. The party was called 'One Kamerun Movement - OK', with Ndeh


Ntumazah as its President. Following its banning, the UPC started a war of liberation in French Cameoon, so Ntumazah from the safety of Southern Cameroons, liaised with his comrades in French Cameroon to carry out their underground operations. Ndeh Ntumazah left Cameroon to seek political asylum abroad in 1962. He stayed in Ghana, Guinea, Algeria and finally in Britain where he spent most of his time sensitising the world about the plight of Cameroon using various avenues like writing, conferences and deputations. Ntumazah is dead, but he lives on because his life stands out as a point of focus.

#### MANAGING A CHANGING CLIMATE IN AFRICA Local Level Vulnerabilities and Adaptation Experiences Chipo P. Mubaya and Pius Z. Yanda


There is sufficient evidence to support the fact that climate change is occurring and that this is set to accelerate. While some scholars argue that climate change is largely due to natural changes, others postulate that anthropogenic factors are the major cause. Climate change associated with increasing levels of carbon dioxide is likely to affect developed and developing countries differentially, with major vulnerabilities occurring in low-latitude regions. This book presents research findings and case studies seeking to inform policies geared towards addressing problems emanating from these changes. Climate variability raises concerns over the future of agriculture, conditions of land and

water availability. Therefore, climate change amplifies many economic and social risks, as well as deterioration of the environment. At the same time, non-climatic risk factors such as economic instability, trade liberalization, conflicts and poor governance all inflict upon vulnerable communities.

Key discussions in this title rest on: Climate Change in Africa: its impact on rural communities, vulnerability and adaptation to climate change, financial requirements of reducing green house gases, technological transfer and natural resources; Case Studies of Vulnerability to Climate Change and Variability in Eastern and Southern Africa: experiences of impacts and adaptation to extreme events, concrete experiences from farmers and crop production adaptation; and Challenges and Opportunities to Climate Change Adaptation: factors that influence choice of response strategies, challenges and opportunities for ecosystem-based approaches; and challenges and opportunities from the use of bio-fuels as a mitigation measure to climate change.


# TAX COMPLIANCE IN TANZANIA Analysis of Law and Policy Affecting Voluntary Taxpayer Compliance Kibuta Ongwamuhana

This book examines the problems of low-level tax compliance in Tanzania. It proceeds from the premise that high-level taxpayer compliance is essential to the success of the tax system. The author argues convincingly that tax enforcement alone (namely, detection and punishment of tax delinquency), will not of itself lead to high-level tax compliance. He posits that there exists a strong link between good governance and taxpayer compliance; tax compliance levels reflecting effectiveness of tax administration, taxpayer attitudes towards taxation and towards government in general. The book focuses primarily on

tax compliance in Tanzania, but it also examines relevant data from the neighbouring countries of Kenya, Uganda, Rwanda, and Zambia, which have undergone tax administration reforms similar to Tanzania and are equally concerned with tax compliance. The author does not limit himself to the African continent; numerous examples are taken from, and references made to cases in the US, Canada, UK, Australia and other developed economies since the fundamental issues about tax compliance are essentially the same everywhere.


#### AFRICA THROUGH THE EYE OF THE VIDEO CAMERA



The issue of how various subjects in law are taught, researched or analyzed, in a world where law has tended to neglect women's experiences as 'subjects of law' is a central concern that academics and researchers need to address. Some of these are traditional legal fields such as jurisprudence, criminal, family, labour and commercial law while others

are specialist areas that need to be engaged with the law. These include issues of social justice, human rights, gender and sexuality, masculinities, and access to resources.





#### THE DEATH OF ASOBO-NTSI

This novel re-visions history through narrative fiction: the history of his people that has long been silenced and distorted as a colonial strategy, the history of an African community at the crossroads. Asobo-Ntsi, the stubborn yet proud Fon of Nyen, is faced with some challenges amongst which are: his seven- and nine-man council that is not happy with his dictatorship and tax laws, a disgruntled quarter that attempts to secede, and also, the encroaching colonialist, Nwuoupang, with his church and administration. How Asobo-Ntsi handles these challenges is expressed powerfully and movingly with great narrative artistry that absorbs the reader and

keeps him/her enthralled to the end.

MBUH TENNU MBUH hails from Pinyin in the North West Region of Cameroon. He obtained his B.A., Maitrise, and Doctorat de Troisieme Cycle in English Literary Studies from the University of Yaoundé (I), and holds a PhD from the University of Nottingham. He is a two-time laureate of the BERNARD FONLON SOCIETY LITERARY AWARD, and a founding member of both the Yaoundé University Poetry Club (YUPOC) and of the Anglophone Cameroon Writers Association (ACWA). Having taught in America as a Fulbright Scholar-in-Resident, Mbuh presently lectures in the Department of English Studies, University of Yaoundé I.





THE DELIVERER Kwabena F. Ankomah-Kwakye

THE DELIVERER received a BURT AWARD FOR AFRICAN LITERATURE 2010. The Burt Award for African Literature is a new literary prize that the recognizes excellence in young adult fiction from Africa.

'Drop the stone, young man!' He screamed. Osei dropped the stone gently on the ground when he realised that the man had no arms and his garments were torn to shreds. He was a frightful sight to behold. With his chest still heaving up and down with rage he turned to find






